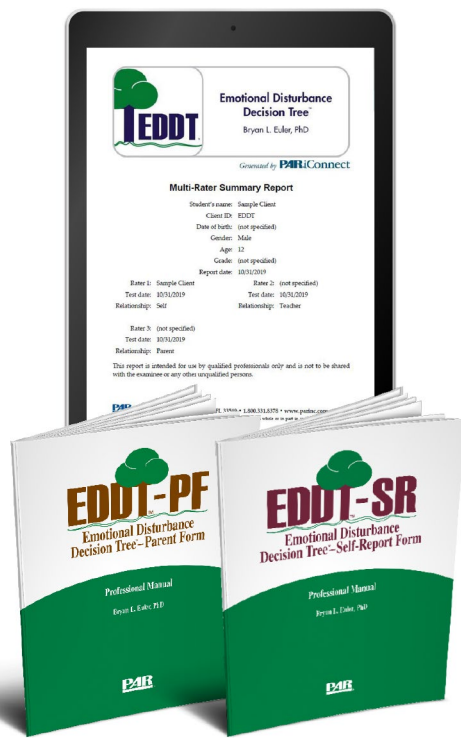


When kids exhibit extreme behaviors, you need tools to cover them all



A roadmap for federal IDEA criteria

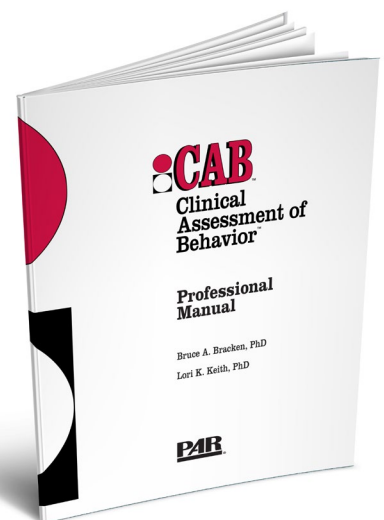
The **Emotional Disturbance Decision Tree™ (EDDT™)** is the first instrument of its kind to provide a standardized approach to the assessment of emotional disturbance in children ages 5 to 18 years and includes scales that map directly to the federal criteria in the Individuals With Disabilities Education Improvement Act of 2004 (IDEA). Administration time is 20 minutes. The EDDT assesses from the teacher's perspective, the **EDDT Parent Form (EDDT™-PF)** assesses from the parent's perspective, and the **EDDT Self-Report Form (EDDT™-SR)** assesses from the child's perspective (ages 9 to 18 years). All three forms are available in paper and pencil or **online administration and scoring via PARiConnect.**

Identify what's really going on

The **Clinical Assessment of Behavior™ (CAB™)** is an objective, comprehensive, and highly reliable behavior rating scale that is closely aligned with diagnostic criteria. Three separate rating forms (Parent Extended [CAB-PX], Parent, and Teacher) contain corresponding items, allowing parents and teachers to contribute equally to the evaluation of target behaviors in children ages 2 to 18 years (5 to 18 years for teachers). Administration time is 10 to 15 minutes (30 minutes for the CAB-PX). Available in paper and pencil or **online administration and scoring via PARiConnect.**

Assess kids' strengths

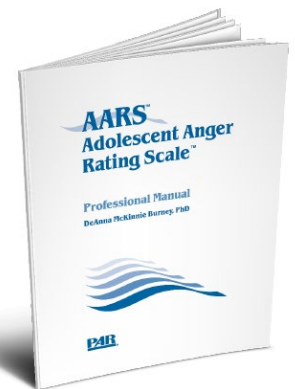
Focusing on a child's strengths, the **Social Emotional Assets and Resilience Scales™ (SEARS)** can be used with children and adolescents (ages 5 to 18 years) who exhibit a variety of clinical problems or who are at high risk for developing such problems. Administration time is 20 minutes. Available in paper and pencil or **online administration and scoring via PARiConnect**.

Evaluate the intensity and frequency of anger expression in adolescents

The **Adolescent Anger Rating Scale™ (AARS™)** is a 41-item psychometrically sound instrument that can help to identify adolescents (ages 11 to 19 years) who are at risk for diagnoses of conduct disorder, oppositional defiant disorder, or ADHD. Administration time is 5 to 10 minutes. Available in paper and pencil.

Analyze threats and intervene appropriately

Following a threat of violence, the **Psychosocial Evaluation & Threat Risk Assessment™ (PETRA™)** enables you to analyze the context of psychosocial, ecological, and coping/resiliency factors to assist in the identification, assessment, intervention and treatment planning, and behavioral management of adolescents (ages 11 to 18 years) who pose a risk of targeted violence toward others. Administration time is 10 to 15 minutes. Available in paper and pencil.
